- Meeting approved the treasurer's recommendation to move the \$2,516.45 surplus from the 2020 budget as follows: \$500 to the Capital Funds Projects Budget for the Meditation Garden, \$1,816 to the Building and Grounds Routine Maintenance Budget to cover the cost of the Fungus Remediation Project and \$200 for a one-time increase to the Fund for Support Annual Budget.

- This statement was developed by American Friends Service Committee, Britain Yearly Meeting, Friends Committee for National Legislation, Quaker Council for European Affairs, and Quaker United Nations Office.

Meeting agreed to create a new structure for responding to emergencies.

- Emergency Coordinators, consisting of the clerk of Meeting, the Treasurer, and the Care Coordinators would be called together by the Clerk of Meeting in the event of an emergency affecting meeting to determine a response.
- They will then bring 'a course of action' for discernment at a regularly scheduled or specially-called Meeting for Discernment.

12 Friends were present at the Meeting House and 4 Friends were present virtually on Zoom

- Meeting agreed to allow a group that would like to use the MFM grounds on a regular basis to meet as a community for meditative ceremonies to process grief and other shared human experiences. MFM appointed Robyn Johnson as the liaison with the group.

Special Called Meeting for Discernment
June 27, 2021

16 Friends were present at the Meeting House and 6 Friends were present virtually on Zoom

- We have been gradually taking steps to fully open our meeting house following its closing during the Covid-19 epidemic. The emergency coordination committee met to make recommendations for the return of our religious education (RE) program and our monthly potluck meal and asked for a special meeting for discernment to minute actions needed to return to full use of the meeting house.

The following recommendations of the Emergency Coordination Committee were approved:

1. Our RE program for children will return on the second and fourth Sundays of each month. The first day of this return of RE will be July 11, 2021
2. RE activities will observe a "2 of 3 Rule," which requires that the teacher and children do two of the three following things at all times: wear masks, maintain six feet of distance between people, and/or be outdoors. We anticipate that the most common practice will be for them to be outdoors and wearing masks during religious education activities.
3. If any children have difficulty practicing the 2 of 3 rule, they will be unable to participate in RE until children can be fully vaccinated.
4. Meeting will revisit these standards when vaccination is available for children under 12.
5. We will return to our previous practice of paying RE teachers at the rate of \$50.00 per time.
6. Should any substitute teachers be needed, teachers will be required to be in compliance with our policy on the protection of children, which mandates a background check.
7. Our Monthly potluck will return to its normal schedule.

Due to the rise of the Delta Virus, a decision was made to continue the “2 out of 3” rule adopted earlier for RE and to eliminate potluck and coffee at meeting until further notice.

A decision was reached to try a spreadsheet to open and close meeting each First Day. The sheet detailing the procedures has been created by Building and Grounds and the clerk of meeting will co-ordinate a sign-up sheet.

- o Meeting approved MFM's *Building & Grounds* proposal to create stone walls on either side of the entrances at Preservation Road and Huguenot Springs Road.
- o Meeting approved adding the role of Youth RE Coordinator as a volunteer position to handle the following:
 - Recommend appropriate number of paid teachers to meet the need at any given time, and interview applicant teachers.
 - Ensure MFM's RE program meets the desires of the meeting's parents and satisfies the teachers' goals, as well as represents the meeting's spiritual objectives for a RE program.
 - Promote, enhance, modify, or expand MFM's RE program whenever needed, based on the coordinator's own ideas and teachers' suggestions that have been approved at *Meeting for Discernment*.

The volunteer coordinator will not be required to teach.

Meeting is grateful that someone stepped forward to be the first RE coordinator. The Youth RE Coordinator was approved.
