#### **Building and Grounds Committee**

The committee brought forward a request for permission to apply to FGC for handicap ramp funding. The deadline for this funding cycle is 3/15/13; FGC announces funding decisions the following year. They may underwrite the entire cost. This would be done no earlier than 2014. Much work remains to apply.

After discussion, it was determined that due to our aging community, MFM approved applying for a grant from the FGC Friends Meetinghouse Fund for \$5,000 towards modifying our meetinghouse to be handicap accessible.

#### **Peace and Social Action Committee**

The 2013 TQ recipient for January is "First Books" to provide books to kids in their home.

Through The Thrifty Quaker (TQ), MFM was able to give \$30,021.71 to twelve different 501(c)3 charities during 2012. All of this represented 100% of the profit from sales at TQ. Since opening in 1996, MFM has given \$344,404.21 in donations as well as an estimated \$1,935,607.12 in goods to other charitable thrift stores and individuals in need. By the "charter" requirements, MFM must use profits for charities.

Likewise, Friend\$hare was able to raise \$21,141.97 during 2012 towards providing financial aid for 24 individuals in crisis. Friend\$hare garners its funds from individual donations of cash, United Way contributions, stew and bake sales, and beginning this past September - from gently used donations.

The clerk opened meeting with a reading of a passage from the draft of the BYM Faith and Practice on meeting for business, pages 86-87.

After a review of the agenda, the clerk welcomed those in attendance including our assistant clerk, Maria Cannady, who will be taking the minutes for us today.

**Spiritual Nurture Committee** - Meeting for Nurture will be held at the rise of meeting on Third First Day in both 2<sup>nd</sup> and 3<sup>rd</sup> Month. In February there will be a small group discussion for approximately 20 minutes to discuss BYM Faith and Practice as a follow-up to something similar in January. On March 17<sup>th</sup> Martha Gay from the BYM Faith and Practice Revision Committee volunteered to visit Midlothian Monthly Meeting to explore our experience with the current draft and to answer any questions or concerns we might have about this proposed Faith and Practice.

**Building and Grounds Committee** – the clerk of B & G spoke about Spring Work Days-March 16<sup>th</sup> from 9am-1pm with **lunch provided**. Focus will be on plantings around the grounds and working on the old shed. Bring tools to work. The hope is also to work on parking lot to even out some of the gravel. She also reported that Ian Johnson came and cut the tree that was threatening the meetinghouse. She intends to get a horticultural expert come and walk the grounds to make recommendations for the property.

The handicap ramp grant application is done and will be signed by our clerk of meeting to be sent this week. A front porch may potentially run the length of the house. The ramp will run from the parking lot to the RE building and then to the meetinghouse. This long porch idea for the front of house would make everything level for wheelchair access and would help make a ramp more pleasing.

**Treasurer's report -** Contributions reveal that MFM ended Jan. 2013 with 112% of the monthly budget. There was one large donation showing a better than usual January because of this generous contribution. By the second Sunday in Feb, contributions are at 66% with two weeks remaining in the month. The budget spreadsheet projects amounts into the future and it currently shows a deficit for the year. This should not be a concern since it is only the sixth week of 2013. Long-term funds for each committee are listed. Each committee can check the spreadsheet to see fund amounts accumulated thus far; however, the entire committee budget can be spent.

**Peace and Social Action Committee** - The February 2013 recipients will be shared between Enterprise VA and VICPP. Madeline's House is the March 2013 recipient.

A report from the current legislative session shows some concerns such as the possible tightening of voter laws, possible increases in interest rates again by payday lending businesses, and also the possible blocking of undocumented workers' children from getting tuition. On the positive side, there is still a ban on uranium mining; the bill to lift the ban was voted down.

The clerk read a letter from a prisoner in Petersburg, VA. His friend, Arthur, is a Quaker at Adelphi Friends Meeting. Arthur's contact information was given as the way to begin a dialogue. If anyone would like to correspond with him, please contact Tom DeWeerd.

Thrifty Quaker (TQ) Annual Board Report – Several handouts were distributed including a list of charities that have benefitted from TQ donations since 1996. In addition, Friend\$hare Grants given by year reveals that Friend\$hare accumulated \$21,000 in 2012. This fund already has \$8,000 for 2013. These funds are used for one-time gifts designated for those in need in the community. The reserve fund for the TQ was explained to be helpful when there are slow months. January 2013 was one of those and has caused the lower than normal reserve fund balance. The store can operate for another month with this trend but both contributions and customers are needed.

**BYM Youth Safety Policy Adoption** – The BYM policy was briefly discussed. The BYM policy is six pages in length and very thorough. BYM has many youth conferences, so they need background checks and training for adults that go to workshops and work with all youth.

Our insurance carrier has requested a questionnaire be completed. If we had a youth safety policy, our insurance would be reduced. It will most likely go up without such a policy.

After discussing the possible adoption of the BYM policy, this topic was held over to give the RE committee time to review and discuss how to proceed. It was recognized that this could take the next several months. The treasurer will let the insurance firm know we are doing this.

**Young Friends** – The children reported on their kindness project. They made magic wands that they will leave randomly around town. Each has a web address and a kindness poem with instructions to do 3 random acts of kindness and pass the wand on. The idea is from kindness girl website. Kindness Girl has a Facebook page for the magic wand kindness project.

Dear Friends.

I am writing at the request of the BYM Financial Stewardship Committee as expressed to me in a phone call earlier this spring and at the apportionment meeting last in Charlottesville. The Meeting for Business of Midlothian Friends Meeting (MFM) and our Financial Stewardship Committee has authorized me to write on our meeting's behalf. Our end-of-the-year 2012 treasurer's report and the 2013 budget submitted raise serious financial concerns.

Similar to what I wrote in 2010, our declining attendance and donations have continued. Our expenses and our current rate of donations reveal that our projected budget could not meet the appropriated amount of \$3,960 for 2013 or the expected 2014 apportionment of \$3,770.

As a small rural/suburban meeting just outside Richmond, we know some of the reasons for what is happening. We have discovered that a significant number of our regular attenders and members have experienced life changes: moving from our meeting area to the city, retiring and thus changing their income, divorce and separation causing serious disruption to their lives including financial stability, and a continued economic slowdown that has serious implications for the local economy including a negative impact on our small community. The single biggest factor, simply put, is that our attendance has declined over the last several years.

A good portion of our budget goes to our mortgages each month. In addition, our meetinghouse has needed some major repairs. Although it is a relatively new home for us, the building itself is not new and we continue to be good stewards of the property by making the needed repairs and improvements.

It is clear that one obligation that MFM will not be able to meet this year and next year is our BYM apportionment. With the information we have at this time, we plan to pay \$2,000.00 to BYM for 2013 and will try to budget \$2000.00 for 2014. This amount will be determined during our budget timeline.

We recognize this is only about 50% of what BYM has requested and that yearly meeting depends on the monthly meeting apportionment to meet its budget. Our community remains committed to our relationship with BYM and we do not take this action lightly. We know the reduced amount will complicate the yearly meeting budget process and will not be easy. We will keep you informed if there are any additional changes. We will also try to send some of our apportionment this summer to help with the BYM operating budget as you have requested.

Dear Friend,

I am writing in response to your recent letter to Howard Brod, our treasurer, asking about the amount of apportionment that BYM received from Midlothian Friends Meeting (MFM) to date this year. I am not sure why you sent this letter as we have already written about this to you. If this was just a "form letter" that is sent out to everyone with amounts filled in, I understand what happened. At the same time, as a member of the financial stewardship committee, I do not think this is the way we should be treating our monthly meetings. It totally ignored our previous communication and the hard work MFM has put into this process. I will read your letter at business meeting this Sunday and this response. Our business meeting and our Financial Stewardship Committee authorized me to write on our meeting's behalf in June. Our end-of-the-year 2012 treasurer's report and the 2013 budget submitted raise serious financial concerns that I expressed then and will repeat some of it here for you again.

Similar to what I wrote in 2010, our declining attendance and donations have continued. Our expenses and our current rate of donations reveal that our projected budget could not meet the appropriated amount of \$3,960 for 2013 or the expected 2014 apportionment of \$3,770.

A good portion of our budget goes to our mortgages each month. In addition, our meetinghouse has needed some major repairs. Although it is a relatively new home for us, the building itself is not new and we continue to be good stewards of the property by making the needed repairs and improvements.

It is clear that one obligation that MFM will not be able to meet this year and next year is our BYM apportionment. With the information we have at this time, we plan to pay \$2,000.00 to BYM for 2013 and will try to budget \$2000.00 for 2014. This amount will be determined during our budget timeline.

We recognize this is only about 50% of what BYM has requested and that yearly meeting depends on the monthly meeting apportionment to meet its budget. Our community remains committed to our relationship with BYM and we do not take this action lightly. We know the reduced amount will complicate the yearly meeting budget process and will not be easy. We will keep you informed if there are any additional changes.

We did send \$1,000.00 to BYM and the only response was that we are not meeting our obligation to BYM. We remain disappointed in the process.
